Within the State of North Carolina mental health & substance abuse services are managed by LME's or Managed Care Organizations. These all have a 24 hour phone line that individuals who have Medicaid or do not have any insurance at all can call in order to access services for mental health, substance abuse or developmental disability. The same services can be obtained by contacting agencies which the department of health & human services have assigned that responsibility to.
